CONSTRUCTION OF LIGHT BUS TERMINUS AT NKPOLU-OROWORUKWO (MILE 3 MOTOR PARK)

INVITATION TO TENDER FOR PREQUALIFICATION/ TECHNICAL AND COMMERCIAL TENDERS

INTRODUCTION

The Rivers State Ministry of Transport hereby expresses her intention to undertake procurement works for the Construction of a Light Bus Park and hereby invites competent and experienced contractors to submit BIDS for the construction of the subject project.

PROJECT OBJECTIVE

The project focuses the construction of a world-class facility that will provide a controlled facility and environment to check pockets of buses, taxis and commuters along the streets and trading in open spaces.

PROJECT DESCRIPTION/SCOPE OF WORK

The proposed Nkpulu-Oroworukwo Bus Terminus (Mile 3 Motor Park) is a multi-level (2) storey parking facility with capacity of 600 No bus parking spaces designed for commercial bus/rick transportation with ultra-modern facilities such as Bank Spaces, Shops, Police Station and other complimentary facilities within the complex.

ELIGIBILITY-MANDATORY REQUIREMENTS:

Interested contractors/bidders in this field are required to submit the following:

1. Evidence of company registration with the Corporate Affairs Commission – Certification of Incorporation; Memorandum and articles of Association; CAC Forms Co7, C02 or CAC Form 1.1 and other relevant documentation.
2. Evidence of VAT registration and Tax registration number (TIN).
3. Detailed Company profile with registered address; not P.O. Box, or P.M.B, functional email, telephone numbers and point of contact for the organization.
4. The company's Rivers State Development Levy receipts for three (3) consecutive years (year of tender inclusive) or intendment to pay.
5. Evidence of payment of Company Tax and returns (tax clearance certificate) for the last three (3) years.
6. Evidence of financial capability (a) Bank reference letter (b) Audited financial Returns/Statements for the last three (3) years.
7. Verifiable evidence of similar jobs successfully executed in the past three (3) years-attach copies of letters of award and completion certificates.
8. Resume /CVs of key technical staff with copies of professional certificate endorsed and evidencing (3) years employment of key staff.
9. Evidence of ownership of equipment, leased or intendment to lease with memorandum of agreement with Leasing Companies for this project.
10. Quality Control/Quality Assurance Procedure Report
11. Anti-Corruption Policy
12. All documents for submission must be transmitted with a covering/forwarding letter under the company's letter headed paper bearing the Registration Number (RC) as issued by the CAC, Contact Address, Mobile Telephone Number, e-mail address and the Names of the Directors of the Company at the bottom of the page and shall be duly signed by an authorized officer of the Firm.

BID SUBMISSION AND CLOSING

Completed Prequalification/Technical and Commercial Priced Bids of Quantities (BoQs) are to be submitted in **3 Three Envelopes** in hard copies and soft copies (CDs) or Flash Drives, as stated below:

- I. **Envelope no. 1: Pre-qualification/Technical/Financial Capability Envelop** – Clearly labeled **Prequalification-Technical Bid Sealed** with Company Seal and signed across seals point.
- II. **Envelope no. 2: Commercial Envelop** – clearly labeled **Commercial Priced Bid Sealed** with Company Seal and signed across seals point.
- III. **Envelope 3: Larger Main Envelop** – containing envelopes (I) and (2) above. Sealed and signed across seals points, ensure tamper proofing. This Third envelop should bear the company name at the reverse sides while the project Name at the Top Right Hand Corner of the Envelope and addressed to the Permanent Secretary Ministry of Transport.
- IV. **Submission Location;** deposit in the bid box located at Permanent Secretary Ministry of Transport Room 919 9th Floor, Podium Block Ministry of Transport.
- V. **The Bid should reach the above address on or before 12:00pm, 18th of January, 2021 Submission Date and Deadline**

- Tender Documents are to be opened immediately after the closing of submission deadline by 12:00pm, 18th January, 2021 at the Ministry of Justice-Hall Rivers State Secretariat Complex, in the presence of bidders or their representatives. Officials of RSBoPP and interested members of the general public are invited to witness the public bid opening exercise accordingly. This publication hereby serves as an invitation for the Bid Opening to all interested members of the public.
- Prequalification/Technical Bid shall be opened first and evaluated –ONLY bidders that pass Technical Prequalification shall have their Commercial bids opened and evaluated.

- a. Ensure you sign the bid submission register at the point of submission as the Ministry will not be liable for misplaced bids.
- b. Late submission will be rejected and shall not be opened.
- c. The Ministry reserves the right to take final decision on any of the documents received in the bid.
